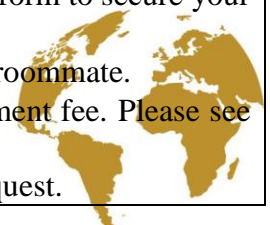

Deposits paid are on a non-refundable basis if the booking is cancelled. Cancellation fee will be levied in the event of a reservation being cancelled. The Company reserves the right to retain the whole or part of the TOUR PRICE paid by the passenger who cancels the tour less than 90 days before the departure date. Please see below for % cancellation.
